  - Support and/or involvement in B.I.G. activities such as annual banquet, scholarship program, fundraisers, other initiatives
  - Attendance at monthly luncheons
- Community Involvement
  - Volunteer/community leadership activities
  - Philanthropic contributions
  - Awards/honors received
- Business Development (for Company award only)
  - Scope of work
  - Employment in Lafourche, Terrebonne, Assumption, St. Mary Parishes
  - Economic value to the community
